Condition 1 of that decision requires the occupation of the dwelling in question to be limited to a person occupied in agricultural work. The dwelling is located outside of the development zone and would not have been permitted to be built without Condition 1.

Cllr Lasota mentioned a few concerns about training a person to weed spray the village.

A. The training cost is ~ £400, but spraying equipment, safety gear and chemicals are significant expenses.

B. Spraying weeds on pavements is not a parish council responsibility.

Cllr Robinson expressed concerns that if we train the Lengthsman he would then be free to do work for any parish.

The Clerk confirmed that WCC would not provide any further funding to pay for spraying or the necessary equipment involved. This means that any work done spraying results in less funds being available for proper Lengthsman work. Chair Howe stated that WCC Cllr Adams stated that he would make sure all spraying invoices are paid by WCC.



#### **CLEEVE PRIOR PARISH COUNCIL**

The Council resolved to obtain further information prior to making a decision.

ACTION: Clerk to confirm that WCC will not increase the Lengthsman budget to cover spraying costs or provide extra funding for spraying equipment.

ACTION: Chair Howe to confirm in writing that WCC will pay all spraying invoices regardless if the budget is exceeded.

ACTION: Clerk to approach Salford Priors PC to investigate the possibility of shared services.
