1 Respective responsibilities of the auditor and the authority

Section 1, Assertion 3 has been incorrectly completed, arrangement for salaries for first 3 months were not in accordance with proper practice such that PAYE and NI requirements were not properly accounted for. This is consistent with the Internal Auditor's response to Internal Control Objective G.
